

Shri Nobom Paka Hina is hereby appointed as Full Time Teacher on contractual basis at fixed salary of ₹. 20,000/- (Rupees Twenty Thousand) only with effect from the date of joining in the concerned School up to 31/03/2015 against Centrally Sponsored Scheme of SARVA SHIKSHA ABHIYAN. He/She is posted at Govt. Upper Pry. School, Bobia.

The engagement is subject to the following conditions: -

- a) The Contractual staff has no right to claim for regular appointment/ regularization of the post after expiry of contract period.
- No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.

- h) The appointed staff has to sign an agreement for contract engagement before receiving this engagement order.
- i) The Salary will be released at school level only after receipt of fund from the Govt. of India/SSA Rajya Mission, Itanagar.
- j) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.-
