ENGAGEMENT ORDER

Miss Ati Taki is hereby appointed as TGT Social Science (Secondary) on contract basis in the fixed pay of Rs. 34,855/ (Thirty four thousand eight hundred fifty five) PM only, with effect from the date of joining in the concern school upto 31/03/2021. The appointment is made against vacancy under central sponsored schemes of Samagra Shiksha/ISSE of Upper Subansiri District, and posted to Govt. Secondary School Sikarijo on office exigency Under Daporijo Educational Block, Upper Subansiri District, Daporijo.

The appointment is subject to the terms and condition of contract assigned between the district project officer, on behalf of State Project Director ISSE, Samagra Shiksha Itanagar and the appointee. The tenure of service will be counted from the date of joining in the concern school further extension shall be subject to satisfactory of performance and extension of project by MoE, GoL.

The engagement is subject to the following terms and condition:-

- a. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b. No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditioned in the agreement copy.
- c. During contract service he/her is not entitle for medical reimbursement. Where allowance, children education allowance, reimbursement of tuition fees, leave travel concession (LTC) special compensatory allowance etc.
- d. The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of issued order. Failing which his/her engagement order will automatically be treated as cancelled.
- e. He/ She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- f. The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g. No representation will be accepted for change of posting place.
- h. The other terms and condition of service which are not specified shall be governed by the relevant rules and order in force time to time.
- i. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
