**ORDER**

Miss Joymoti Bingap is appointed to the post of Lab. Technician on temporary adhoc basis against the vacant post of Smti J.P Saikia, Ex-Lab. Technician (who has retired on superannuation) on pay scale of (PB-1) Rs. 5,200-20,200/- + Grade Pay 2400/- and other allowances as admissible under rules from time to time in Arunachal Pradesh.

This offer of temporary adhoc appointment is subject to fulfillment of the following conditions and regularization by DPC in future.

1. She will have to produce two certificates of character and antecedents from a gazetted officer under Govt. or stipendiary (Certificates from educational authority or honorary magistrate will not suffice).
2. She will have to produce a medical certificate from a DMO/CMS to the effect that she is fit for Govt. service.
3. The temporary adhoc appointment may be terminated at any time after giving notice for one month without assigning any reason. If she wants to resign from service, she will have to give notice for one month.
4. The other conditions of service, which are not specified herein, shall be governed by relevant rules and orders in force from time to time.
5. No TA/DA will be allowed for joining the post.
6. She should report to the Jt. DHS (T & R) Pasighat for duty within 1 (one) month from the date of issue of this order failing which the appointment will be treated as cancelled.
7. Her pay and allowances may be drawn under Non Plan Head in Leprosy. Head of Account (Non-Plan) 2210-Med & PH, 06-Public Health, 101-P & CD, 04-LCP-00-01-Salaries.
8. She is posted to General Hospital, Pasighat.


