HEST-90/94 :: :: :: Shri Yeafow Bangyang is appointed temporarily to the post of Pharmacist (Allopathy) in the Medical Department, Govt. of Arunachal Pradesh with effect from the date he reports for duty on pay Rs. 4500/-P.M. in the scale of Rs. 4500-125-7000/-P.M. plus other allowances as admissible under rules from time to time in Arunachal Pradesh.

The offer of appointment is on subject to fulfilment of the following conditions.

1. He will have to produce to certificates of character and antecedents from Gazetted Officer under Govt. or from stipendar Magistrate (Certificate from educational authority or from Honorary Magistrate will not suffice).
2. He will have to produce a Medical Certificate from a Govt. Gazetted Medical Officer not below the rank of Civil Surgeon/CMO/DMO to the effect that he is fit for Govt. Service.
3. The appointment is purely temporary and may be terminated at any time without assigning any reason giving notice for one month. If he wants to resign from service will have to give one month notice.
4. He will have to remain on probation for a period of 2 years from the date of appointment of other wise the post is continued.
5. NO TA/DA is admissible for joining the post.
6. He should report District Medical Officer, Ziro, Lower Subansiri District, AP. against Damin Sub-Centre for duty within one month from the date of issue of this order failing of which the appointment will be cancelled.
7. The other conditions of service which are not specified herein will be governed by the relevant rules and orders in force from time to time.
8. He is posted to Damin, Sub-Centre, Lower Subansiri Dist. AP.
