ORDER

Sri/Smt. Rolan Ransang W/O. D/o of Sri/Lt/te Sihonah Ransang is hereby appointed as LDC in the scale of Pay (PB-1) of Rs. 5,200-20,200 + GP 1,900/- P.M plus other allowances as admissible from time to time from the date of joining at the place of posting. The appointment is made against the vacant post of LDC vice Sri/Smt L. Ransang promoted as UDC /expired/Newly created post vide Govt. of Arunachal Pradesh order No. _____

The appointment is purely temporary and on probation for a period of 2 (two) years from the date of joining. The service will be regularized on satisfactory completion of 2 (two) years of probation period. The service is liable for termination at any time by giving one month notice without assigning any reason or in lieu thereof on payment of one month salary. In case the appointee wants to resign, he/she too would be required to give one month notice thereof to the appointing authority.

As per Govt. Notification No. DAP/PEN/11/04 of 17th Nov' 2007, the new appointee who were appointed on or after 1/1/2008 shall not be eligible for the CCS pension Rule, 1972 so far in vogue in the state/GPF shall not be applicable to him.

Other terms and conditions of services which are not specified herein will be governed by the relevant Rules in force from time to time.

His/Her Head quarter is fixed at Longding and attached to SDAO's Office Longding

The expenditure is debit to the Head of Account _____ of Salary.

TERMS AND CONDITIONS

1. He/She has to qualify/pass the computer typing speed of 35 words per minute which will be conducted by March 2013 or else service will be terminated accordingly.
3. He/she is directed to submit medical certificate of fitness in prescribed forms/Oath of Allegiance to the Constitution of India/Oath of Secrecy (Form enclosed) and also Character certificate from 2 (two) Gazatted Officers or from Principal of College/School last attended and Village Head (GB) or Chief at the time of joining.
2. He/she should also submit attestation Form for police verification within 1 (one) month to this office for necessary action. If in due course of verification, if any of the information is found adverse, legal action will be taken and his/her service will be terminated automatically.
