SUB: OFFER OF APPOINTMENT TO THE POST OF LADY CONSTABLE IN APP CIVIL POLICE

You have been provisionally selected for appointment against the temporary vacancies of **Constable** in **APP Civil Police** in the scale of pay of **Rs. 3050- 75-3950-80- 4590** /- pm plus other allowances as admissible from time to time. Your appointment will be subject to the following terms and conditions :-


- a) Successful completion of basic training.
- b) True and sufficient disclosure of informations by you while filling up each and every column of the attestation form.
- c) Satisfactory verification of character and antecedents. On verification, if any adverse remarks are received regarding character and antecedents, your services will be terminated forthwith.
- d) The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof
- e) You will be on probation for a period of two years.
- f) You are required to serve anywhere in the districts and places of Arunachal Pradesh, where you are posted and detailed.
- g) You are required to serve at least for three years from the date of joining, unless you are discharged or dismissed or certified by a civil surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he has to refund the cost of training i.e. pay drawn during the period of training plus the expenses of T.A. to join the training school.
- h) You have to undergo Police basic training at recognised Police Training Centre as ordered by the authority concerned and ensure proper attendance and observe full discipline in the Training Institute.
- i) The CCS (Pension) Rule-1972 so far in vogue in the state /GPF shall not be applicable to you.

The other terms and conditions of service which are not specified herein shall be governed by relevant rules and orders of Government of A.P. in force from time to time.

If you are willing to accept the appointment on the terms & condition's mentioned above, you should report at PTC Banderdewa on **1-2-09** positively for basic training. The formal appointment order will be issued after your joining.

You should bring with you light bedding, personnel clothing, one stainless steel plate (full size,) one mug (500 ml) and Rs. 2500/- (Rupees one thousand five hundred) for being mess charges etc.

In case you fail to report on the date mentioned above, your candidature will automatically be cancelled.
