**ORDER**

Miss Nabam Rita is hereby engaged as A/T on contract basis in the fixed pay of Rs. 7200/- (Rupees Seven Thousand Two Hundred only) against Centrally Sponsored Scheme of SARVA SHIKSHA ABHIYAN. She is posted at Govt. Primary School, 7 D Colony under Itanagar Circle.

The engagement is subject to the following conditions:-

- The Contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- During contract service period she is not entitled for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), Special compensatory allowance etc.
- The contract teacher have to report her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned EAC, failing which her engagement order will automatically be treated as cancelled.
- She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- The engaged teacher is also to work as volunteer instructor for TLC Programme for the interest of the library in Arunachal Pradesh in addition her normal duties.
- No representation will be accepted for change of posting place.
- She will have under go DIET training at concerned DIET for training as and when call for.
- The validity of contract periods is up to 31/3/2008, which may be extended by seeing the performance/ regularity of teacher as recommended by the concern V.E.C.
- The other terms and conditions of service which are notified shall be governed by the relevant rules and other in forced time to time.
