2. He/she has to produce a Medical Certificate from the Gazetted Medical Officer not below the rank of civil surgeon/CMO/DMO to support his/her fitness for Govt. service.
3. He/she should report to DMO (West Kameng) Bomdila, for further posting order/duty within twenty (20) days from the issue of this order failing which the appointment will automatically stand cancelled.
4. The Appointees shall be on probation for a period of two years. The services can be terminated by giving one month notice from either side.
5. No TA/DA is admissible for joining the post.
6. All MTS posts are district-specific. No representation for inter-district transfer shall be entertained.
7. Other terms & conditions which are not specified herein will be governed by the relevant Rules & orders in force from time to time in Arunachal Pradesh.
