**O R D E R**

Shri Taliang Tatung, is hereby appointed temporarily to officiate as Junior Teacher [Social Studies] in the PB-2 of Rs. 9300-34800 + GP Rs. 4600/- PM plus other allowances as admissible under rules from time to time with effect from the date he actually reports for duty to the Principal, Govt. 7. The seniority of the appointee shall be based strictly on merit list.
