- NO. MEST-97/46 : The Governor of Arunachal Pradesh is pleased to appoint Dr. Sang Khandu Thungon an Arunachal Pradesh Govt. nominee to the post of Medical Officer on ad-hoc basis with effect from the date of joining the post in the scale of pay of Rs. 2200-75-EB-100-4000/- Pm plus 15% and other allowances as admissible under rules in force from time to time in Arunachal Pradesh.
2. As per terms and conditions of the letter executed by Dr. Sang Khandu Thungon at the time of admission to the MBBS course, he will have to serve in Arunachal Pradesh for a minimum period of 3 (three) years.
 3. Other terms and conditions of service which are not specified herein will be governed by the relevant rules and orders in force from time to time in Arunachal Pradesh.
 4. In the interest of Public Service Dr. Sang Khandu Thungon is posted to General Hospital, Naharlagun temporarily. His formal posting will be issued in due course.
 5. Further, Dr. Sang Khandu Thungon will have to appear before the Selection Board of Arunachal Pradesh Public Service Commission for the purpose of regularisation of his ad-hoc appointment as and when called for. However, ad-hoc appointment will not confer any right to claim seniority over others till regularisation of ad-hoc service.
