Santi Hakulu Mawong an APST candidate is hereby appointed as **Female Attendant** from the approved panel in the scale of pay of Rs. 4440-7440 (2000-12P)P.M. plus other allowances as admissible to the Govt. of Arunachal Pradesh employees from time to time against the newly created post vide order No. M.D.V-15/2009/015 Dated, Itanagar, on 07th August 10.

1. **The terms and conditions of this appointment are as under:-**
 - (i) The appointment is on probation for a period of 24/week years and may be regularised on successful completion of probationary period.
 - (ii) The appointment is purely temporary and may be terminated at any time by a month's notice giving by either side viz. the appointee or the appointing authority. The appointing authority however reserves the right to terminate the services of appointee forthwith or before the expiry of the stipulated period of notice by making payment to him/her a sum equivalent to the pay and allowances for the period of notice or unexpired portion thereof.
 - (iii) The appointment is subject to satisfactory verification reports of character and antecedents and any adverse report is received, the services shall be terminated forthwith.
 - (iv) Taking an Oath of allegiance/faithfulness to the Constitution of India or making solemn affirmations to that effect in the prescribed form on joining.
 - (v) The appointment is subject to the production of medical fitness certificate from not below the rank of Civil Surgeon.
 - (vi) The appointment carries the obligation to serve in any part of Anjaw District.
 - (vii) One character certificate/original should be produced from the Gazetted Officer not below the rank of Class-II status (State or Central).
2. Other terms and conditions of services, which are not specified herein, shall be governed by the relevant rules and orders in force from time to time.
3. The appointment shall take effect from the date of his joining in the office of **Community Health Centre, Itanaj**.
4. The expenditure is defensible to the Head of Accounts.


