MEMORANDUM.

Shri/Smti Jaba Gaone

is hereby informed that he has been selected for appointment to the post of LDC/JDC in the scale of pay of Rs. 950-20-1150-EB-25-1500/2 p.m. The appointee will also be entitled to draw other allowances and concessions in force from time to time to the Arunachal Pradesh Government employees.

The terms of the appointment are as follows :

1. The appointment will be on probation for a period of 6 months to be extended by a further period of 6 months.
2. The appointment may be terminated at any time by 1 (One) month's notice given by either side such as viz; appointee or the appointing authority, without assigning any reason. The appointing authority, however, reserves the right of termination of such of the appointment forthwith before the expiry of the stipulated period of notice by making payment to him/her, or a sum equivalent to the pay and allowances for the period of notice as the unexpired portion of notice thereof.
3. The appointee is to serve at any interior place of Upper Subansiri District, Arunachal Pradesh. Failure to comply with this condition will be considered a disqualification and lead to the appointment being treated as cancelled.
4. As per the condition mentioned in the para -3 above, you are posted to C.O.'s office Sijuan
5. The appointment is subject to production of certificate of Fitness from Civil Surgeon/ District Medical Officer and original Educational Qualification Certificate.

6. Submission of declaration regarding marital status in the form enclosed (Annexure-I).
7. Taking an oath of allegiance/faithfulness to the constitution of India (or making of a solemn affirmation to that effect) in the prescribed form (Annexure-II) on joining.
8. Production of the release order from the previous employer/resignation is to be tendered from his previous appointment/whichever is applicable as per rule).
9. No TA/DA is entitled for joining to his/her place of posting on appointment.
10. He/She will have to sign a declaration to abide by the official Secrets Act in presence of the undersigned.
10. If any declaration given or information furnished by the appointee proves to be false or found to have wilfully suppressed any material ~~information~~ he/she will be liable to be removed from the service and or such action as Govt. may deem necessary.
11. If Shri/Smti Jaba Gane..... accept that offer on the above terms he/she should communicate his/her acceptance to the undersigned on or before 30/11/95 with the submission of declaration forms and documents of certificate as stated above. If no reply is received by the stipulated date, the offer will be treated as cancelled.
