ORDER

On the basis of recommendation of DPC held on 06/05/2010 & approval conveyed by the competent authority vide U.O.No.SE/ICC/HPD/E-25/2010-11/249 dtd.06/05/2010, the appointments of following officiating adhoc LDCs under Department of Hydro Power Development are regularized from the date of issue of this order, in the scales of pay of Rs.5200 – 20200 + Grade Pay – 1900/- Plus other allowances admissible under rules from time to time.

The terms and conditions of the regularization will be as follows :-

1. Their service will be governed by the CCS (Temporary Service Rules) 1965 as amended upto date.
2. He/she is required to submit an acceptance letter based on this regularization order.
3. The appointment/regularization carries with the liability to serve in any part of Arunachal Pradesh or outside where the Arunachal Pradesh Hydro Power Development Department has an organization or as decided by the Govt. from time to time in the interest of public service.
4. His / her services are liable to be terminated by the Govt. at any time without assigning any reason but ordinarily one month's notice will be given. If he / she wishes to resign he / she will have to submit his / her resignation and wait for its acceptance by the Govt. In case he / she goes away without its acceptances, he / she will be treated as having been dismissed from service with a disqualification for future employment under the Government of Arunachal Pradesh.
5. He / she is required to produce a certificate of good character from a 1<sup>st</sup> Class Magistrate or from 2(two) Gazetted Officer who are known to him.
