Further, the above appointees will have to follow the following terms and conditions :-

- I. The teacher appointed under SSA shall have to serve anywhere in the district.
- II. Extension of contractual service to the second year / successive years will be subject to satisfactory performance and regularity in service in the previous year.
- III. The appointed teacher will have no right to claim for regularization.
- IV. On completion of the contract period of every term the appointment stands terminated automatically.
- V. T.A. & D.A for appearing in the interview and for joining in the service are not permissible.
- VI. The appointed teacher shall have to undergo in-service training and orientation training programme organized by the department as and when required.
- VII. It will not be binding on the part of the appointing authority to provide residential accommodation to the appointed teachers.
- VIII. The contractual teacher shall have to sign a deed of agreement before receipt of appointment order. The terms and conditions mentioned in the agreement will be strictly adhered to for the entire period of contractual service.
- IX. They should join in the office of D.P.O. within 7 (Seven) days failing which their appointment may be cancelled for the next waiting list.
