" ORDER "

Sri/Smti Yopiam Mize is appointed to the Post of SFS under NAMP on temporary basis in the Medical Deptt. Govt. of Arunachal Pradesh with effect from the date he/she reports for the duty on pay B. 2550/- P.M. in the scale of pay of B. 2550-55-2660-60-3200/- P.M. Plus other allowances as admissible under rules from time to time in Arunachal Pradesh.

The offer of appointment is on temporary basis and subject to fulfilment of the following conditions :-

- 1) He/She will have to produce 2(two) certificates of character antecedents from Gazetted Officer under Govt. or from stipendary Magistrate (certificate from educational authority or from Honorary Magistrate will not suffice).
- 2) He/she will have to produce a Medical Certificate from Govt. Gazetted Medical Officer not below the rank of Civil Surgeon/CMO/DMO to the effect that he/she is fit for Govt. duty.
- 3) The appointment is purely temporary and may be terminated at any time without assigning any reason giving notice for one month. If she/he wants to resign from service he/she will have to given one month notice.
- 4) He/she will have to remain on probation for a period of 2(two) years from the date of appointment if other wise the post is continue.
- 5) NO TA/DA is admissible for joining the post.
- 6) He/she should report to the DMO, Podisai for duty within 30(thirty) days from the date of issue of this order failing of which the appointment will be cancelled.
- 7) The other conditions of service which are not specified herein will be governed by the relevant rules and orders in force from time to time in Arunachal Pradesh.
- 8) He is posted at Ruksin CHC
