c) During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowances etc.

d) The Second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and

any other departmental engagement.

f) He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of

contract services.

h) No representation will be accepted for change of posting place.

- i) He/She will have to under go DIET training at concern DIET for Training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- 1) The contract service shall be terminated by the undersigned on receipt of substantive complaint from the concerned NGO/ DDSE/ DC of the district.
