regularization on completion of the probation period based on satisfactory performance of duty
during the tenure.
3. The appointment is temporary and liable for termination by giving 30 (Thirty) days notice or by
paying equal amount of pay and allowance in lieu of notice period from either side.
4. The incumbent must report for duty at the posting place within 30 (Thirty) days failing which the
appointment will automatically be treated as cancelled.
5. The joining in service is subject to production of following documents.

female Medical Officer of the similar rank.
