The candidate will have to take an oath of allegiance to the constitution of India and also an oath under the official secret act at the time of appointment.

They will have to furnish details of their movable and immovable properties within four weeks from the date of joining. Similarly, they will also have to furnish the details of their family members.

The appointment will be governed by relevant rules and orders of Govt. of Arunachal Pradesh issued from time to time.
