- The appointment has been initially made for a period of 2 (Two) years on probation, subject to regularisation on completion of the probation period based on satisfactory performance of duty during the tenure.
- The appointment is temporary and liable for termination by giving 30 (Thirty) days notice by paying equal amount of pay & allowances in lieu of notice period from either side.
- The incumbent must report for duty at the posting place within 30 (Thirty) days, failing which the appointment will automatically be treated as cancelled.
