PROVISIONAL APPOINTMENT ORDER

Shrimati Hichoh is hereby appointed provisionally to officiate as Asstt. Teacher Grade 'A' under the Education Department Govt. of Arunachal Pradesh and posted to Govt. Mukto Vill. Pry. School, Mukto in the scale of pay of Rs. 1200-30-1560-EB-40-2040/-p.m. plus other allowances as admissible under the rule from time to time with effect from the date of joining duty in the office of the Deputy Director of Public Instruction, Tawang District, Tawang.

The appointment is subject to the following conditions :-

1. The appointment is purely temporary and may be terminated at any time without assaining any reason after giving one month notice from this end.
2. After joining duty she will have to take on oath of allegiance to the constitution of India duly signed in the prescribe form.
3. She had to produce a medical fitness certificate from an authorised Medical Officer to the effect that she is medically fit for Govt. service.
4. The appointment is subject to the police verification on A.P.S.T. Certificate (In case of Arunachal Pradesh candidate) and she will be discharged from service with immediate effect if there be any adverse remarks against her in the police reports and S.T. Certificate.
5. The appointment is in probation for 2 years. There cases for regularisation in the Grade of Asstt. Teacher 'A' do depends on their pre performance in duties.
6. Formal appointment order will be issued by Director of Public Instruction, Govt. of Arunachal Pradesh, Naharlagun from the date of joining in the office of the Dy. Director of Public Instruction, Tawang.
7. She is directed to submit two copies of character certificate from the gazetted officer before joining in service.
