**MEMORANDUM**

The undersigned hereby offers **Shri Nokman Kimsing** a temporary post of **Security Assistant (Executive)**, in the pay band of Rs. 5200-20200/- + Grade Pay of Rs. 2000/-. The appointee will also be entitled to draw dearness and other allowances at the rates admissible under the rules and orders governing the grant of such allowances in force from time to time, and subject to the conditions laid down therein. He/ She will be required to undergo necessary training successfully at the places selected by the Director, Intelligence Bureau.

2. The terms of appointment are as follow:-

(i) He/She will be on probation for a period of 2 years, which can be extended by the appointing authority. If during the period of probation or any extension thereof, as the case may be, the appointment authority is of the opinion that he/she is not fit for permanent appointment, that authority may discharge him/her from service. During the period of probation or any extension thereof, he/she will be required by the Government to undergo such courses of training and instructions and to pass examination test (including examination in Hindi) as Govt. may deem fit, as a condition to satisfactory completion of the probation. The probation will be subject to instructions/guidelines issued by the Central Government from time to time.

(ii) The appointment is temporary. His/ Her appointment to the post in permanent capacity will, however, will depend on various factors/rules governing permanent appointment in such posts in force at that time and will not confer him/her the title of permanency from the date the post is converted.

(iii) The appointment may be terminated at any time by a month's notice given by either side viz. the appointee or the appointing authority, without assigning any reason. The appointing authority, however, reserves the right of terminating the service of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.

(iv) He should declare within one month of his joining the IB, whether he had applied for any post in other Government Department or Public Sector Undertaking.

(v) The appointment carries with it the liability to serve in any part of India.

(vi) Other condition of service will be governed by the relevant rules and order in force from time to time.

3. The appointment will be further subject to:-

(i) Submission of declaration in the form enclosed (copy enclosed) that he/she does not have more than one wife living or being married to a person having more than one wife living, unless exempted from the enforcement of the recruitment in this behalf.

(ii) Taking of an oath of allegiance to Constitution of India in the prescribed form (copy enclosed).

(iii) Production of the following original certificates:-

- a. Certificate of age (with the attested copy)
- b. Certificate/mark sheet of educational from matriculation onwards and other technical qualifications (with one attested copy)
- c. Character Certificate from two Gazetted Officers (form enclosed).
- d. Certificate in the prescribed form in support of candidate's claim to belonging to SC/ST/Anglo Indian Community or OBC (with one Attested copy) .
- e. Discharge certificate in the prescribed format from previous employment, if any.
- f. Any other documents (to be specified)

4. If any declaration given or information by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he/she will be liable to removal from service and such other action as the Government may deem necessary.

5. If accepts the offer on the above terms, he/she should report to the **Assistant Director/E, Subsidiary Intelligence Bureau, (MHA), Govt. of India, Old SSB WATTS, Gohpur Tiniali, Chimpur, PO: R. K. Mission, Itanagar, Arunachal Pradesh – 791113** on or before **01-01-2016**. In case he/she fails to report for duty on the prescribed date, the offer will be treated as cancelled.

6. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he/she will be liable to removal, from service and such other action as the Government may deem necessary.


7. No traveling allowance will be allowed for joining the appointment.

8. His/her appointment would be covered under the new Pension Scheme introduced by Govt. of India w.e.f. 01-01-2004.

9. The appointment is provisional and is subject to the Caste/Tribe/OBC Certificate being verified through proper channels and if the verification reveals that the claim of his/her belonging to the Scheduled Caste/Scheduled Tribe/OBC as the case may, if false, his/her service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates.

10. On joining, he/she will be required to enroll himself/herself as a member of the Intelligence Bureau Relief Fund, which is constituted for the benefit of the members of the Bureau.

11. He/She is further directed to let the undersigned know, within 15 days of from the date of issue of this letter whether he/she is willing to join the bureau on this post subject to his/her being found medically fit. In case the willingness of the candidate is not received within the stipulated time, it will be presumed that he/she is not interested and his/her case will be closed at our end.
