- d) He / she will have to produce Medical fitness Certificate from an authorized Medical Officer.
- e) The appointment is subject to the Police Verification and he/ she will be dismissed from Govt. service if there is any adverse report from the Police.

g) The appointment order shall be cancelled, if the appointee directly or in-directly campaigns for change of place of posting or does not join within 10(ten) days from the date of issue of this order.
