On recommendation by the Arunachal Pradesh, PSC, the Governor of Arunachal Pradesh is pleased to appoint the following persons as Assistant Engineer (Civil) in the Arunachal Pradesh, PWD, in the scale of pay of Rs. 2000-60-2300-EB-75-3200-100-3500/- per month plus other allowances as admissible under rules from time to time in the interest of public service. They will be on probation for a period of 2 (two) years with effect from the date of joining in their respective place of posting as shown below :-

The terms and conditions of appointment will be as follows:-

2. Their services will be governed by the CCS (Temporary service Rules) 1965 as amended upto date.
3. The appointment carries with it the liability to serve in any part of Arunachal Pradesh or outside where Arunachal Pradesh Public Works Department has an organisation as decided by the Government from time to time in the interest of public service.
4. The candidates will have to taken an oath of allegiance to the Constitution of India and also an oath under the official secrets Act, at the time of taking up appointment.
5. They will have to furnish details of their movable and immovable properties within four weeks from the date of joining. Similarly, they will also have to furnish the details of his family members.
6. Their appointment will be governed by relevant rules and orders of Government of Arunachal Pradesh issued from time to time.

SC/ST candidates will have to furnish a certificate of fitness from Medical Board. A certificate issued by the Civil Surgeon/District Medical Officer can be accepted provisionally.

The candidate should not have more than one wife at any time through out his service.

No TA/DA will be permissible for the joining the post offered.

Other terms and conditions which are not specified herein at all be governed by the relevant rules and orders issued by the Govt. of Arunachal Pradesh from time to time.
