MEMORANDUM

As per the recommendation of the selection committee Shri Sokanso Tayang is hereby offered a purely temporary appointment as Junior Engineer(Electrical) on the following terms and conditions :-

- 1) An initial pay of Rs.5500-175-9000/-P.M.Plus other allowances as admissible under rules.
- 2) The appointment will take effect from the date of his/her actual joining of duty.
- 3) No traveling allowance will be admissible for joining this appointment.
- 4) No gratuity or pension will be admissible for the officiating service but he/she may be granted leave under the revised rules 1972 as amended from time to time.
- 5) The appointment carries with it the liability to serve in any part of Arunachal Pradesh or outside where the Arunachal Pradesh Power Department has an organization.
- 6) His/her services are liable to be terminated by the Govt. at any time without assigning any reason but ordinarily one month's notice will be given. If however, he/she wishes to resign he/she will have to submit his/her resignation and wait for its acceptance by the Govt. In case he/she goes away without its acceptance, he/she be treated as having been dismissed from service with a disqualification for future employment under the Govt.
- 7) He/She is required to produce a Certificate of good character from a first Class Magistrate or from 2 (Two) Gazette Officers who are known to him/her for the last 3 (Three) years but not related to his/her before he/she is allowed to join the department.
- 8) Original Certificates and testimonials in support of his/her qualification, age, caste should be produced before joining duty.
- 9) If he/she has been employed anywhere previously he/she will have to submit a discharge certificate from his/her last employer.
- 10) In case it is proved after the acceptance of the appointment that he/she is a dismissed employee of the Union or state Government disqualifying him/her for future employment under the Govt. or that he/she will be dismissed from service without any remuneration.
- 11) In case it is proved after the acceptance of the appointment that qualification, age and other Certificate are not genuine as required under rules, he/she will be dismissed from service and may be prosecuted under Indian Penal code.
- 12) In case it is also established that he/she is not a bonafide candidate and he/she has obtained employment by direct and false representation, he/she will be dismissed from service and may be prosecuted under Indian Penal code.
- 13) The offer of appointment is subject to the following conditions.
 - a) He/She is an Indian National.
 - b) He/She will not keep more than one spouse at any time throughout his service.
 - c) His/her services will be terminated if he/she is found to be alcoholic.
- 14) He/she will have to take an oath or allegiance in the name of constitution of India at the time of taking up of the appointment.
- 15) His/her appointment will be provisional subject to his/her character and antecedents being verified by the Police authorities. A medical fitness certificate from CMO/DMO/CIVIL SURGEON is also to be produced at the time of joining.

- 16) He/She will have to fill in a declaration of temporary service on joining of the department.
- 17) He/She will be governed by the Classification control and appeal rules etc. as framed by the Government of Arunachal Pradesh from time to time.
- 18) He/She will have to declare the details of his/her movable & immovable properties within 4 (Four) weeks from the date of his/her appointment. Similar information will have to be furnished in respect of his/her family members.
- 19) He/She will not leave the department on offer received from any other deptt. where he/she might have applied before nomination here. Also he/she will not apply direct for any post outside the Arunachal Pradesh Power Department.
- 20) He/She will have to give his/her hometown declaration within 7 (Seven) days.
- 21) SC/ST candidates will have to furnish a Certificate in the prescribed form in support of candidate claim to belong to SC/ST community.
- 22) He/she will be on probation for 2 (Two) years. The period of probation may be extended at the discretion of the appointing authority. During the period or probation he/she will be required to do such duty as Govt. may prescribed. Failure to complete the period of probation to the satisfaction of the competent authority will render him liable to discharge from service.
- 23) His/her appointment will be governed by the relevant rules and orders of the Government issued from time to time.
- 24) If any declaration given or information furnished by the candidates proved to be false at any stage or if the candidate is found to have willfully suppressed any materials information he/she will be liable to be removed from service and or such other action as Government deem necessary.
- 25) If he accepts offer on terms and conditions given above he may report to the Executive Engineer(E), Deomali Electrical Division, DOP, Deomali on or before 5th Jan,2006. He is posted to Longding vice Shri R.C. Roy, J.E.(E) already transferred to Namsai under H.E.D. If the candidates fails to report for duty by the prescribed date the offer will be treated as cancelled.
- 26) On receipt of communication he/she should intimate at once whether he/she is willing to join the post on the above terms and conditions.
- 27) He will have to pass depttl. Test in simple Accounts as specified within 2 (two) years from the date of joining duty failing which his second increment and future increments will be withheld until he passes the said examination.
- 28) The formal appointment order shall be given only after receipt of application in plain paper through proper channel duly certified by the Controlling Authority. The candidate should comply with all the terms and condition as mentioned above before applying for the formal appointment. The offer is liable for cancellation or rejection if such application is not submitted within the probation period.
- 29) Other rules and regulations not stated herein but promulgated by the Govt. from time to time will be applicable in his case.
