OFFICE ORDER

Sri Kating Dai is hereby offered the post of Assistant Urban Programme Officer (AUPO) on a purely temporary basis and posted under District Urban Development Agency (DUDA), Changlang, on the following terms and conditions: -

1. The initial pay shall be Rs. 5,500/- per month in the scale pay of Rs. 5,500-175-9000/- per month plus other allowances as admissible under rules.
2. The appointment will take effect from the date he/she actually joins duty as per this offer of appointment.
3. No TA/DA shall be paid to the appointee for joining duty.
4. Gratuity of pension will be admissible as per CCS rules as amended from time to time.
5. He/She is liable to serve in any place wherever Urban Development Department of the Government of Arunachal Pradesh operates.
6. His/Her appointment will be purely temporary and liable to be terminated on 1(One) month notice from the either side.
7. He/ She is required to take oath of allegiance to the Constitution of India on the date of joining.
8. He/ She is required to produce 2 (Two) Character Certificates from any Gazetted Officers known to him/her for at least last 3 (Three) years to this appointment before joining.
9. He/she will be on probation for a period of 2 (Two) year.
10. Original Certificates and Testimonials in support of his/ her Qualification, age and scheduled tribe certificate should be produced at the time of joining the post. If he/she has been employed anywhere, he/ she shall bring a discharge certificate or release order from the previous employer.
11. If he/ she served in any Department under the Govt. of Arunachal Pradesh on Adhoc basis the period shall not be counted for fixing his/ her seniority.
12. He/ she shall produce 2 (Two) Passport size Photographs on the date of joining the post.
13. His/ Her appointment will be subject to his/ her being declared Medically fit for Govt. service by a Competent Govt. Physician.
14. He/ She should not have more than one spouse living at any time through out his/ her service except recognized under customary/ personal laws.
15. Seniority shall be maintained as per the order of merit.
16. In case, if it is proved after the acceptance of the appointment that he/ she is a dismissed employee and disqualified by the Union/ State Govt. for future employment under any Govt. service or he/she obtained employment using false certificates etc. he/she shall be dismissed from service without any remunerations.

17. The confirmation of the service shall be subject to passing of Departmental induction course and examinations as prescribed by this office like passing of examination simple accounts prescribed for Junior Engineers (JEs) of CPWD and successful completion on Central Sector scheme particularly Swarna Jayanti Shahari Rojgar Yojana.
18. If he/she accepts the offer on the terms given above he/she should report for duty in the office of the District Urban Development Agency (DUDA), Changlang, within 30 (Thirty) days from the date of issue of this offer failing which this offer of appointment shall be treated as cancelled automatically. No transfer allowance shall be entertained for posting after the induction course.


