
The appointment to the post of Lady Constable in APP (Civil Police) shall be subject to the following conditions:-

1. Timely report to their respective training centre, failing which shall liable to rejection of the candidature.
2. Will have to undergo Police Basic Training and ensure proper attendance and discipline in the Training Institute.
3. Successful completion of basic training.
4. The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
5. Will be on probation for a period of two years.
6. Will be required to serve at least for 3 years from the date of joining, unless discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he/she has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training school.
7. They are required to serve anywhere in Arunachal Pradesh or outside the state where posted or detailed.
8. The inter-se seniority in the rank of Constable will be determined on the basis of marks obtained on completion of basic training.
9. No TA/DA will be admissible to join at PTC Banderdewa for basic training.

The other terms and conditions of service which are not specified herein shall be in accordance with the relevant rules in force from time to time.

Candidate willing to accept the terms and conditions mentioned above, should report to Principal PTC Banderdewa on 01-05-2014 repeat 01-05-2014 for further basic training along with 1. Personal belongings, 2. Approx. Rs.2500/- as mess advance and security advance, 3. Admit Card issued during recruitment
