SUB: OFFER OF APPOINTMENT FOR THE POST OF HEAD CONSTABLE(T) & RT
IN ARUNACHAL PRADESH POLICE (CIVIL POLICE /AAP BN/ IRBN).

On being found medically fit and subject to satisfactory verification of the character & antecedents, you have been provisionally selected for the post of Head Constable(T) & RT against the existing temporary vacancies of Head Constable(T) & RT in Arunachal Pradesh Police (Civil Police /AAP BN/ IRBN) in the pay band of PB-I, Rs. 5,200- 20,200/- + Grade pay Rs. 2400/- (Initial pay will be fixed at Rs. 7510/- + Grade pay Rs. 2400/-). Your continuation in service shall be subject to the following conditions:

1. Successful completion of basic training.
2. True and sufficient disclosure of the information while filling up each and every column of attestation form.
3. Satisfactory verification of character and antecedents. If any adverse remarks received about the character and antecedents, the service shall be terminated forthwith.
4. The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
5. You will be on probation for a period of two years.
6. You are required to serve at least for 3 years from the date of joining, unless you are discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training school.
7. You are required to serve anywhere in Arunachal Pradesh where posted or detailed. If appointed against IRBN, you will have to serve in Arunachal Pradesh and even outside of the state if deployed.
8. The inter-se seniority in the ranks of respective cadre will be as per the marks secured in the examination after basic training where marks are allotted and on the basis of performance/merit in the recruitment for the post where marks are not allotted in the basic training.
9. No TA/DA will be admissible to join at PTC for basic training.
10. You have to undergo Police Basic Training at PTC Banderdewa and ensure proper attendance and discipline in the Training Institute.
11. The CCS(Pension) Rule-1972 and GPF Rule shall not be applicable to them.

The other terms and conditions of service which are not specified herein shall be in accordance with the relevant rules in force from time to time.

If you are willing to accept the above post of Head Constable (T) & RT in APP (Civil Police/AAP BN/IRBN) in the pay band + Grade pay and conditions mentioned above, you should report to Principal PTC B/Dewa on 01-09-2011 along with personal belongings, light bedding and approx. Rs. 4,000/- as mess advance for further basic training.
