2. He shall not be permitted to work as per central civil service rules and to perform his duties in the government office.
3. He shall not be entitled for regular reimbursement while attending his duties in the government office. He shall be entitled for regular reimbursement of travel expenses, if any, special allowances, honorarium and any other such allowances.
4. The engaged officer has to report his duty at posting place within 7 days from the date of joining in the concerned DDC's office failing which his engagement order will automatically be considered cancelled.
5. He shall not be entitled to subscribe GPF / CPF or such other schemes during the period of contract engagement.
6. The engaged officer is also to work as volunteer instructor of T.E.T. / P.T.E. program for the benefit of District of Amritsar District in addition to his normal duties. Further, he is engaged to also attend to various other duties assigned by the District / District Administration, Punjab Government in any manner as may be required during.
7. No compensation will be granted for change of posting place.
8. He shall not be entitled for DDC / training as concerned DDC for training as per when called for.
9. The terms and conditions of service which are not specified shall be governed by the relevant rules / orders / instructions in force at that time.
10. The engaged officer has to sign an agreement for contract engagement before receiving the engagement order.
11. The contract period will extend till only up to 31st May 2008 and thereafter it will be treated as contract period and a fresh contract would be required.
12. He shall have to report his duty at his / her posting place positively on 01st June 2008. His / her duty will be considered as if he / she is not present from the concerned A.P.O. (A.I.) A.D.O.
