(2) The appointees shall be on probation for a period of 2 (two) years from the date of their joining, and probation shall be regularized subject to satisfactory performance.

(3) The appointment may be terminated at any time by a month's notice given by either side, viz, the appointee or the appointing authority, without assigning any reason thereof. The appointing authority, however, reserves the right to terminate the service of the appointee forthwith or without any notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.

(4) If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have wilfully suppressed any material information, he/she shall be liable for removal from service and such other action as Government deem necessary.

- (vi) No TA will be allowed for joining on appointment.
- (vii) The appointee shall join the service in the Department of Law, Legislative & Judicial, Government of Arunachal Pradesh, Itanagar within 15 days from the date of the issue of this appointment order, failing which the appointment order shall stand cancelled.
