ORDER

In pursuance of Govt. approval vide U.O. No. Nil Dated 03/03/2008 the service of Shri/Smti/Miss Tapang Gammi is hereby regularized temporarily to officiate as Assistant Teacher(A) in the Scale of Pay of Rs.4500-125-7000 p.m. plus other allowances as admissible under Rules from time-to-time w.e.f. she actually reports for duty to the DDSE, Tezu, Lohit District, Arunachal Pradesh. He/She is posted under disposal of DDSE, Tezu. He/She is appointed against Shri R.C. Deka, AT(A) retired.

The appointment shall be on probation for a period of 02(two) years w.e.f. the date of joining. His/Her continuation in service beyond probation period for 02(two) years is subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:

- a) The appointment is purely temporary and will be terminated with 01(one) month notice. If He/She wants to resign, he/she may do so after giving 01(one) month notice or by surrendering 01(one) month salary.
- b) The continuation of service will be subject to satisfactory performance of duty during probation period.
- c) After joining He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if any adverse report is there with immediate effect

The terms and conditions of-service which are not specified herein shall be governed by the relevant Rules & Orders in force from time-to-time.
