ORDER

Shri/Smt/Miss **Monj** Morang is hereby engaged as **HTT** A.T (A) on contract basis on the fixed pay of Rs 7200/- (Rupees Seven thousand two hundred) only with effect from the date of joining in the concerned district upto 31/3/2007 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He / She is posted at Primary/Upper Primary School,Langtang. The engagement is made free resignation/expiry waiting panel not joined or Staff/Smt/Miss. Application in case of resultant vacancies.

The engagement is subject to the following conditions:-

- a) The contract Teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement
- b) No Parted leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy
- c) During contract service period he/she is not entitled for medical reimbursement, winter allowance, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), Special compensatory allowance etc
- d) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned DPO (District Project Officer) failing which his/her engagement order will automatically be treated as cancelled
- e) He/She is not entitled to subscribe GPF or CVHS or such other schemes during the period of contract service
- f) The engaged teacher is able to work as volunteer instructor for TEC programme for the interested interview in Arunachal Pradesh in addition to his/her normal duties
- g) No representation will be accepted for change of posting place
- h) He/She will have to undergo DTEI training at concerned DPO for training as and when call for
- i) The other terms and conditions of Service which are not specified shall be governed by the relevant rules and orders in forced time to time
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order
