On recommendation of District Selection Board held on 23.10.2016, Chow Koksia Mokrun is hereby appointed on Temporary basis to the post of Cook against the post created vide order No.MDEV-39/14 dated 13.04.2016 in the dept. of Health & Family Welfare, Govt. of Arunachal Pradesh w.e.f. the date he reports for duty in the scale pay (PB-1) Rs.5200-20200/- + G.P. 1800/- P.M. plus other allowances as admissible from time to time in the state of Arunachal Pradesh.

The appointment is subject to fulfillment of the following conditions:

1. He has to produce two certificates of character and antecedents from the Gazetted officer under Govt. or from stipendiary Magistrate (Certificate from educational authority or from honorary Magistrate will not suffice.)
2. He has to produce a Medical Certificate from the Gazetted Medical Officer not below the rank of Civil surgeon/CMO/DMO to the effect that he is fit for Govt. service.
3. No TA/DA is admissible for joining in the post.
4. His posting place will declare by the establishment of the District Medical Officer, Namsai, district Namsai, A.P. He should report to the District Medical Officer, Namsai, district Namsai, A.P. for duty within 30(thirty) days from the date of issue of this order failing which the appointment shall automatically stand cancelled. No further correspondence will be made in this regard.
5. All MTS posts are district-specific. No representation for inter-district transfer shall be entertained.
6. The other terms & conditions which are not specified herein will be governed by the relevant rules & orders in force from time to time in Arunachal Pradesh.
7. The pay & allowances of above appointment may be drawn under the following Head of Accounts:
