**MEMORANDUM**

On the basis of the Written Examination followed by Viva-voce/Personality test, **SHRI MODO PADU (Wait Listed)** is hereby offered a purely temporary appointment as **JUNIOR ENGINEER (CIVIL)** on the following terms and conditions:-

1. This offer of appointment will carry an initial pay of **Rs.5,500/-** in the scale of pay **Rs.5,500-175-9,000/-** (pre-revised scale) per month plus allowances as admissible under rule.
2. The appointment will take effect from the date of his/her actual joining of duty at the place of posting for the purpose of drawal of pay & allowances.
3. No traveling allowance will be admissible for joining at the place of posting.
4. No gratuity or pension will be admissible for the officiating service but he/she may be granted leave under the revised rules 1972 as amended from time to time.
5. The appointment carries with liability to serve in any part of Arunachal Pradesh or outside where the ARUNACHAL PRADESH HYDRO POWER DEVELOPMENT DEPARTMENT has an organization.
6. **His/her** services are liable to be terminated by the Govt. at any time without assigning any reason but ordinarily one month's notice will be given. If however, he/she wishes to resign, he/she will have to submit his/her resignation and wait for its acceptance by the Govt. In case he/she goes away without its acceptance, he/she will be treated as having been dismissed from service with a disqualification for future employment under the Government of Arunachal Pradesh.
7. **He/she** is required to produce a certificate of good character from a First Class Magistrate or from 2(two) Gazetted Officers who are known to him/her for the last 3(three) years but not related to him/her before he/she is allowed to join the Department.
8. Original certificates and testimonials in support of his/her qualification, age, caste/tribe should be produced before joining duty.
9. **If he/she** has been employed anywhere previously he/she will have to submit a discharge certificate from his/her last employer.
10. In case it is proved after the acceptance of the appointment that he/she is a dismissed employee of the Union or State Government disqualifying him/her for future employment under the Govt; he/she will be dismissed from service without any remuneration.
11. In case it is proved after the acceptance of the appointment that qualification, age and other certificates are not genuine as required



- under rules, he/she will be dismissed from service and may be prosecuted under the Law.
12. In case it is also established that he/she is not a bonafide candidate and he/she has obtained employment by direct and false representation, he/she will be dismissed from service and may be prosecuted under the Law.
  13. The offer of appointment is subject to the following conditions:-
    - a) He/she is an Indian National.
    - b) He/she will not keep more than one spouse at any time throughout his/her service.
    - c) His/Her services will be terminated if he/she is found to be an alcoholic.
  14. **He/She** will have to take an oath of allegiance in the name of constitution of India at the time of taking up of the appointment.
  15. **His/Her** appointment will be provisional subject to his/her character and antecedents being verified by the Police authorities. A Medical fitness certificate from C.M.O./D.M.O./Civil Surgeon is also to be produced at the time of joining.
  16. **He/She** will have to fill in a declaration of temporary service on joining of the Department.
  17. **He/She** will be governed by the Classification Control and Appeal rules etc. as in force under the Government of Arunachal Pradesh from time to time.
  18. **He/She** will have to declare the details of his/her movable and immovable properties within 4(four) weeks from the date of his/her joining. Similarly, he/she will give declaration in respect of his/her family members and his/her hometown.
  19. **He/She** will not leave the department on offer received from any other department where he/she might have applied before nomination. Also he/she will not apply directly for any post outside the Arunachal Pradesh Hydro Power Development Department.
  20. **APST candidates** will have to furnish ST certificate in the prescribed form in support of his/her claim of belonging to APST community.
  21. **He/She** will be on probation for 2(two) years. The period of probation may be extended at the discretion of the appointing authority. During the period of probation, he/she will be required to do such duty as Government may prescribe. Failure to complete the period of probation to the satisfaction of the competent authority will render him/her liable to be dismissed from service.
  22. **His/Her** appointment will be governed by the relevant rules and orders of the Government issued from time to time.
  23. **He/she** will have to pass Departmental Examination in simple accounts as specified within 2(two) years from the date of joining of duty, failing which his/her second increment and future increments will be withheld until he/she passes the said examination, besides extension of the probation period.
  24. If any declaration given or information furnished by the candidate is proved to be false at any stage or if the candidate is found to have



willfully suppressed any material information, he/she will be liable to be removed from service and/ or such other action as Government may deem fit.

25. Whenever he/she is posted in charge of stores, he/she will have to deposit a security as fixed by the Department from time to time in cash or through fidelity bonds as per rules in force.
26. If he/she accepts offer on terms and conditions given above, he/she may report for duty to the office of the **Executive Engineer, Hayuliang Civil Division, Department of Hydro Power Development, Hayuliang** within 30(thirty) days from the date of issue of this order failing which the offer will be treated as cancelled.
27. The formal appointment order shall be given only after receipt of application in plain paper through proper channel duly certified by the controlling authority on successful completion of the probation period. The candidate should comply with the terms as mentioned above before applying for the formal appointment. The offer is liable for cancellation or rejection if such application is not submitted within the probation period.
28. He / She shall not be eligible for the General Provident Fund (GPF) subscription as per Government Notification vide No.DAP/PEN/11/2004 dated 17/11/2008.
29. Other rules and regulations not stated herein but promulgated by the Government from time to time will be applicable in his/her case.
