O R D E R

Miss Csing Pedung, Peon, Ruksin Secondary School is hereby promoted and appointed as A/T(A) under the Education Department, Govt. of Arunachal Pradesh and posted against the vacant post of Shri G.R. Pegu, A/T(A), East Siang district resigned in the scale of Pay of Rs. 1200-30-1560-BB-40-2040/- p.m. plus other allowances as admissible under the rules from time to time with effect from the date on which she reports for duty to the DDPI, East Siang.

2. The officer shall be on probation for period of 2(two) years with effect from the date of joining. Her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.
3. The appointment is subject to the following condition.
 - (a). The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one month notice. If she wants to resign may require to give one month notice or surrender one month salary.
 - (b) After joining in the duty she have to oath of allegiance of affirmation to the constitution of India in the prescribed form.
 - (c) She will have to produce Medical Fitness Certificate in prescribed form from an authorised Medical Officer.
 - (d) The appointment is subject to Police Verification and she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
4. The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and order in force from time to time.
5. She shall be transferred to Schools any where in Arunachal Pradesh.


