
**ORDER**



Their continuation in service will be subject to the following terms and conditions:-

- Successful completion of basic training.
- True and sufficient disclosure of informations by them while filling up each and every column of the attestation form.
- Satisfactory verification of character and antecedents. On verification, if any adverse remarks are received regarding character and antecedents, their services will be terminated forthwith.
- The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
- They will be on probation for a period of two years.
- They are required to serve in IRBN only & anywhere in the districts and places of Arunachal Pradesh, in any State/UT of India and in any where they are posted and detailed.
- They are required to serve in IRBN at least for three years from the date of joining, unless they are discharged or dismissed or certified by a civil surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he has to refund the cost of training and i.e pay drawn during the period he was under training plus the expenses of T.A. to join the training school.
- They have to undergo Police basic training at recognised Police Training Centre as ordered by the authority concerned and should have proper attendance and observe full discipline in the Training Centre.
- The CCS (Pension) Rule – 1972 so far in vogue in the State/General Provident Fund (GPF) shall not be applicable to them.
