Sub:- Offer of Appointment for the Post of Constable (AAP Bn / IRBN) in APP whose C & A verification has not confirmed.

On being found medically fit and subject to satisfactory verification of the character & antecedents, the candidates shown under Annexure IV (A) have been provisionally selected for the post of constable against the existing temporary vacancies of constable (AAP Bn / IRBN) in APP in the Pay Band -I, Rs.5200 - 20,200/- + Grade Pay Rs. 2000/-.

The appointment to the post of constable (AAP BN / IRBN) in APP shall be subject to the following conditions:-

1. Satisfactory verification of Character and Antecedents.
2. Timely report to their respective training centre as indicated. Failure to report to training centre on stipulated date shall liable to rejection of the candidate.
3. You will have to undergo Police Basic Training and ensure proper attendance and discipline in the Training Institute.
4. Successful completion of basic training.
5. The appointment will be purely temporary and may be terminated at any time without assigning any reason(s) thereof.
6. Will be on probation for a period of two years.
7. Will be required to serve at least for 3 years from the date of joining, unless you are discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training school.
8. The personnel appointed against AAP Bn will have to serve anywhere in AP where posted or detailed. The personnel appointed against IRBN will have to serve in Arunachal Pradesh as well outside of the state if deployed.
9. The inter-se seniority in the ranks of respective cadre will be as per marks secured in the examination after basic training where marks are allotted and on the basis of performance / merit in the recruitment for the post where marks are not allotted in the basic training.
10. No TA/DA will be admissible to join the duty.

The other terms and conditions of service which are not specified herein shall be in accordance with the relevant rules in force from time to time.

The candidates willing to accept the terms and conditions mentioned above, should report to Principal PTC Banderdewa on 9th April 2013 repeat 9th April 2013 for further basic training along with 1. Personal belongings; 2. Light bedding, 3. Approx. Rs.2,500/- as mess advance, 4. Steel Plate / Mug / Spoon and 5. Admit card issued during recruitment for authentication / identification of candidates reporting for training.

The formal appointment order shall be issued only after joining at respective training centre.
