Shri Asurut Pertin, B.A. B.Ed. is hereby appointed to officiate J/T(S/B) in scale of pay of Rs. 5500-175-9000/- p.m. plus other allowances as admissible under rules from time to time with effect from date he/she actually reports for duty to RDSE, Anini.

2. The appointment is made vice Shri Shrikant Shukla, Junior Teacher(S/B) expired.

3. The officer shall be on probation for a period of 2 (two) years with effect from the date of joining. His/her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

4. The appointment is subject to the following conditions :-

- a) The appointment is purely temporary and may be terminated at any time without assigning any reasons. If he/she wants to resign he may do so after giving one month's notice or by surrendering one month pay.
- b) After joining the duty he/she shall have to take an Oath of allegiance of affirmation to the constitutions of India in the prescribed form.
- c) He/she will have to produce Medical fitness certificate in prescribed form from an authorized Medical Officer.
- d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
- e) The other terms and condition of services which are not specified herein, shall be governed by the relevant rules and order's in force from time to time.

5. Shri Asurut Pertin, B.A. B.Ed shall have to continue for a minimum tenure of 5 (five) years term in his present posting place.
