The terms of appointment are as follows:-

- (a) The appointment is temporary and may be terminated at any time after giving one month notice from either sides without assigning any reason. Appointing authority however reserves the right of terminating the Services of the appointees(S) forth-with or before the expiry of the stipulated period of notice by making payment to him/them of a sum equivalent to

the pay and allowances for the period of notice. If the appointee(s) wish to resign from Services or fail to give one month clear notice as aforesaid he/they shall have to pay one month salary in lieu of the notice.

- (b) The appointment carries with it the liabilities to serve any part of Arunachal Pradesh.
- (c) The appointment will be initially on probation for a period of 2(two) years from the date of joining to the post.
- (d) Other conditions of Services will be subject to his/their being found fit on verification of character and antecedents.

The appointment will be further subject to:-

- (a) Production of a certificate of a fitness from the District Medical Officer/Civil Surgeon.
- (b) Taking an oath of allegiance/faithfulness to the constitution of India (or making of a solemn affirmation to that effect in the prescribed forms on joining to the place of duty.
