Further their continuation in service will be subject to the following conditions :-

- a) Successful completion of basic training.
- b) True and sufficient disclosure of information's by them while filling up each and every column of the attestation form.
- c) Satisfactory verification of character and antecedents. On verification if any adverse remarks are received regarding character and antecedents, their services will be terminated forthwith.
- d) The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
- e) They will be on probation for a period of two years.
- f) They are required to serve at least for three years under APP from the date of joining, unless they are discharged or dismissed or certified by a civil surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he has to refund the cost of training and i.e pay drawn during the period he was under training plus the expense of T.A. to join the training school.
- g) They have to undergo Police basic training at North Eastern Police Academy, Umsaw, Barapani, (Meghalaya) as ordered by the authority concerned.

h) Their interse seniority in the rank of Sub-Inspector will be determined on the basis of marks secured at the time of recruitment and marks secured at the conclusion of basic training in term of circular No. PHQ/TRG/NGO/32/85 dtd. 21/05/1986.

The other terms and conditions of service which are not specified herein shall be governed by relevant rules and orders of Government of A.P. in force from time to time.


