OFFICE ORDER

In pursuance and approval conveyed by the Chief Engineer, Deptt. of Hydro Power Development Itanagar vide NO.CE/HPD/E-III/1/07-08/3898-99, Dtd.11/10/07, the appointment of the following officiating UDC's under Namsai Circle, DHPD Namsai Arunachal Pradesh are hereby regularized on purely temporary basis from the date(s) shown against each in the scale pay of Rs.4500-125-7000/- pm . plus other allowance admissible under rules from time to time as under:-

The terms and conditions of the regularization are as follows :-

- 1) Their services will be governed by the CCS(Temporary Service Rule) 1965 as amended upto date.
- 2) The appointment /regularization carries with it the liable to serve in any part of Arunachal Pradesh or outside where the Arunachal Pradesh Hydro Power Development Department has an organization or as decided by the Govt. from time to time in the interest of Public Service.
- 3) He/she is required to submit an acceptance letter based on this regularization order. If he/she wishes to resign , he/she will have to submit his/her resignation and wait for its acceptance by the Government . In case, he/she goes away without its acceptances, he/she will be treated as having been dismissed from service with a disqualifications for future employment under the Govt. of Arunachal Pradesh.
- 4) He/she is required to produce a certificate of good character from a 1st class Magistrate or from 2(two) Gazetted officers who are known to him/her for last 3(three) years but not related to him/her while submitting acceptance letter.
- 5) Original Certificates and testimonials in support of his/her Qualification, age and caste should be produce again while submitting the acceptance letter.
- 6) In case, it is proved after the acceptance of the regularisation order that he/she is a dismissed employee of the Union or state Govt. he/she is liable to be dismissed from service.
- 7) In case, it is proved after the acceptance of the appointment /regularization that Qualification , age and other certificates are not genuine as required under rule,he /she will be dismissed from service and shall be prosecuted under law.
- 8) He/she will have to take an oath of allegiance in the name of constitution of India and also an oath under the official secrets Act at the time of submitting acceptance letter.
- 9) The Offer of appointment/regularisation is subject to the following conditions:-
 - a) He/she is an Indian National.
 - b) He/she will not keep more than one spouse at any time throughout his/her service.
 - c) His/her service will be terminated if he/she is found to be alcoholic subsequently.
