is hereby engaged as *PT*.....on contract basis in the
fixed pay of Rs. *8,500/-*.... (Rupees *Eight thousand five hundred*) only
with effect from the date of joining in the concerned post-
ing place upto 31st March, 2008 against centrally sponsored
scheme of Sarva Shiksha Abhiyan. He/She is posted at *Primary/*
Middle School... *Pullong*.....

The engagement is subject to the following
conditions:-

- a) The contract Teachers have no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
- b) No earn leave is permissible except casual leave as per central Civil Service Leave rule and as per terms and conditions in the agreement copy.
- c) During contract service period he/she is not entitled for Medical re-impoursement, Winter Allowances, Children's Educational Allowances, Reimbursement of Tution Fees, Leave Travel Concassion (LTC) Special Compensatory Allowances etc.
- d) The contract Teachers have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDPF, Failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- f) The engaged Teacher is also to work as Volunteer Instructor for TLC Programme for the interest of Literacy in Arunachal Pradesh in addition to his/her normal duties.

- g) No representation will be accepted for the change of posting place.
- h) He/she will have to undergo DIET Training at Changlang DIET for training as and when called for.
- i) The other terms and conditions of the services which are not specified shall be governed by the relevant rules and order in force from time to time.
- j) The engaged Teacher has to sign an agreement for contract engagement before receiving this engagement order.
