Miss Amo Wangsu is hereby appointed as **Accountant** in place of **Miss Phejoi Wangsu** under **District Project Office SSA Zilla Mission Longding** on contractual basis in the fixed pay of Rs. 19,910/- (Rupees Nineteen Thousand Nine Hundred Ten)only per months with effect from date of joining against centrally sponsored scheme of **Sarva Shiksha Abhiya**. The appointment is subject to the following terms and conditions:-

- 1) The contractual service has no right to claim for regular appointment/regularisation after expiry of contract appointment.
- 2) No earn leave is permissible except casual leave as per central civil service rule and as per terms and conditions.
- 3) During the contractual service period he/she is not entitle for medical re-imbusement, Winter Allowances, Children's Education Allowances, Re-imbusement of Tuition fees, Leave Travel Concession (LTC) Special Compensatory Allowance etc.
- 4) The contractual service have to report His/her duty at posting place within 7 (seven) days from the date of joining the office of District Project Officer, Longing. Failing which his/her appointment order will be automatically be treated as cancelled.
- 5) He/ She is not entitled to subscribe GPF or CGEGIS or such other schemes during the period of contract service.
- 6) The appointed contractual service is also to work as volunteer instructor for TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to His/her normal duties
- 7) No representation will be accepted for the changing of posting place.
- 8) The other terms and conditions of the service which are not specified shall be governed by the relevant rules and order enforce in time to time.


