MEMORANDUM

In accordance with sub-rule (b) of Rule 5 under Part -III, of Arunachal Pradesh Civil Service Rules 2006 as amended from time to time, the Governor of Arunachal Pradesh is pleased to offer appointment to Shri Nvarik Diyum, Sub Inspector, Arunachal Pradesh Police, C/O AIGP, PHQ, Itanagar, to the post of APCS(EG) by selection as a Departmental candidate, through lateral entry, under the Government of Arunachal Pradesh in the scale of pay in Pay Matrix Level 10( PB3 Rs 15600-39100+5400GP, Pre-revised)pm plus other allowances and concessions admissible under Rule from time to time with effect from their date of Joining, subject to the final outcome of the following writ petitions pending before the Hon'ble Gauhati High Court, Itanagar permanent Bench, Naharlagun, Arunachal Pradesh.

- (i) WP(C)No 89(AP)/2017 filed by Shri Tania Hakom and 15 Ors Versus State of AP and 24 Ors.
- (ii) WP(C) No 139(AP)/2017 filed by Shri Tania Hakom and 16 Ors Versus State of AP and 23 Ors.

2. The terms of offer of appointment are as follows:-

- a) The appointment may be terminated at any time by a month's notice given by either side, viz. the appointee or the appointing authority, without assigning any reason. The appointing authority, however reserves the right to terminate the service of the appointee forthwith or before the notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- b) The appointment carries with it the liability to serve in any part of Arunachal Pradesh as well as in the establishments of Government of Arunachal Pradesh located outside Arunachal Pradesh, which shall be under the discretion of the Government.
- c) Other conditions of service will be governed by the relevant rules of Arunachal Pradesh Civil Service Rules 2006 as amended from time to time and also by Rules/ orders issued by government of Arunachal Pradesh from time to time.

3. The appointment will be further subject to:-

- a) Production of a Certificate of Fitness from the Medical Board, appointed/authorized by the Govt. of Arunachal Pradesh.
- b) Submission of Declaration in the Form (Annexure-I) enclosed and in the event of the candidate having more than one wife living or being married to a person having more than one wife living, the appointment will be subject to his/her being exempted from the relevant Rules of CCS (Conduct) Rules, 1964 in this behalf.
- c) Taking an Oath of Allegiance & Faithfulness to the Constitution of India (or making of a
