- (3) The appointment is purely temporary and may be terminated at any time without assigning any reasons by giving notice for one month. If she wants to resign from service will have to give one month notice.
- (4) No TA/DA is admissible for joining the post
- (5) They should join their posting place within 15(fifteen) days from the date of issue of this order failing which appointment will stand cancelled and no representation for the alteration will be considered .
- (6) The conditions of service which are not specified herein will be governed by the relevant rules and orders in force from time to time in Arunachal Pradesh.


