In pursuance of Government Approval Vide U.O. No.Nil dated 12.08.2009 Shri Kenjum Kamgo is hereby appointed temporarily to officiate as Senior Teacher (Geography) in the Pay Band-2 of Rs. 9300-34,800 + GP- Rs.4800- p.m. and other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duty to the Principal, Government Higher Secondary School, Koloriang, Kurung Kumey District, Arunachal Pradesh.

The appointment is made against newly created post vide order No.ED3/41/2005-06 dated 14/08/2008.

(A) The appointment is subject to the following conditions:-

- (i) The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining. His/Her continuation in service beyond probation for 2(two) years is subject to satisfactory performance during probation period.
- (ii) The appointment is purely temporary and may be terminated with 1(one) month's notice. If He/She wants to resign, he/she may do so after giving 1(one) month's notice or by surrendering 1(one) month's salary.
- (iii) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty.
- (iv) After joining duty he/she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (v) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (vi) The appointment is subject to the Police Verification and he/she will be dismissed from Government service if any adverse report is there with immediate effect.
- (vii) He/She shall remain in the place of posting minimum 3(three) years from the date of joining. No representation/campaigning for the change of posting place shall be entertained before completion of minimum 3(three) years of service.

Other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
