The appointment is subject to the following conditions.

1. The post is transferable and liable to serve in any part of Arunachal Pradesh, where the department is having such establishment.
2. The appointment has been made on probation for a period of 2(two) years w.e.f the date of their joining at the place of posting. Further retention of their service beyond the probation period is subject to satisfactory performance of duty during the period mentioned.
3. The appointment is subject to verification of character and antecedents and liable for termination subject to receipt of adverse report there upon.
4. The joining in service is subject to production of Medical fitness certificate from a Medical Officer not below the rank of DMO/CMO.
5. The incumbent must report for duty at his posting place within 30(thirty) days from the date of issue of this order, failing which the appointment order will be treated as cancelled.
6. During the probationary period, the incumbent should acquire minimum proficiency in computer applications.

The other terms and conditions of services which are not specified herewith will be governed by the relevant rules and orders issued from time to time.

The Inter-se-seniority will be fixed in due course as per existing Rules.


