- (4) No TA/DA is admissible for joining the post.
- (5) They should join their posting place within 30 (thirty) days from the date of issue of this order failing which appointment will stand cancelled and no alternation will be considered subsequently on personal representation.
- (6) The condition of service which are not specified herein will be governed by the relevant rules and orders in force (from time to time in A.P.


