c. Appointment may be terminated at any time by one month's notice given by either side viz. the appoint or the appointing authority. The appointing authority however reserves the right of terminating the service of the appointee forthwith or before the expiry of the stipulated period of notice by making payment of sum equivalent to the pay and allowances for the period of notice or unexpired portion thereof.

d. The other terms and conditions which are not specified herein shall be governed by the rules and orders in force from time to time.

e. Medical fitness certificate to be obtained from a Civil Surgeon.

f. Production of the following in original :-

a. Educational qualification certificate.

b. Certificate of Age.

c. Character certificate from a Dist. Magistrate or Gazzeted Officer.

2. If any declaration given or information furnished by him/her proves to be false or is found to have been willfully suppressed he/she will be liable to removal from service and such other action as competent authority may deem necessary.

3. The appointment will stand cancelled if he/she fails to report/join duties at the place of posting within 10 (ten) days on issue of this order.

4. The appointment is further subject to the outcome of the Case(s) pending in the Hon'ble High Court of Gauhati.
