**ORDER**

Shri Geh Ete Sia Lane Taps Ete Village Bogdo, PO/PS, Aalo West Siang District, A.P. is hereby appointed as LDC on purely temporary basis in the scale of pay PB.I. Rs. 5280/- 1820/- Grade pay per month plus other allowances as admissible from time to time with effect from the date of joining at his posting place. He is posted at ADC office Yomcha.

Shri Geh Ete on joining, shall be on probation for a period of 2 (Two) years and his service shall be regularized only on completion of satisfactory probation period.

The service is purely on temporary basis and shall be liable to be terminated with 1(one) month notice from either side.

The appointment is against vacant post created on promotion of Shri Kima Sora (Saya), LDC as LDC.

The appointment/joining are further subject to:-

1. Production of medical certificate of fitness from an authorised Medical Officer in prescribed form.
2. Taking an oath of allegiance and faithfulness to the Constitution of India.
3. Verification of character and antecedents.
4. Submission of declaration of details of family.

As per Govt. Notification No. DAPPEN/11/2004 dated 17<sup>th</sup> November, 2007, the appointment to the new entrant/recruitment on or after 01-01-2008 is eligible for New Pension Scheme and the existing CCS (Pension) Rule 1972/GPF Rule 1960 is not applicable.

Other terms and conditions of appointment which are not specified herein will be governed by relevant rules and orders issued from time to time.


