1. The appointment has been made initially on probation for a period of 2(two) years. Further retention in the service will be subject to her good performance in the post and verification of characters and antecedents.
2. The post is transferable and liable to serve in any part of Arunachal Pradesh where the department is having such establishment.
3. The incumbent is to submit the followings at the time of joining in service.
 - (a) Medical fitness certificate from a female Medical Officer not below the rank of CAS-I.
 - (b) Oath of Secrecy.
 - (c) Oath of allegiance to the constitution of India.
4. She should report to her respective place of posting within 30(thirty) days from the date of issue of this order, failing which this offer of appointment will be treated as cancelled.
5. The other terms and conditions of service which are not specified herein will be governed by the relevant rules issued from time to time.
